Subject: Re: R1206013 Email Ruling Confirming PHC Rulings

Dear ALJs McKinney and Halligan:

This email is in response to the e-ruling below, dated May 15, 2014, requiring the IOUs to provide dates and locations for public participation hearings (PPHs) for Phase 1 of R.12-06-013. SCE sent an email to the service list on May 21 suggesting that PPHs be held in Temple City and San Bernardino sometime between August 11 and September 12.

SCE received feedback from the Office of Ratepayer Advocates, the Utility Reform Network, CALSEIA and Vote Solar.

With respect to the dates, the responding parties indicated a preference not to hold PPHs before intervenor testimony is due, and their consensus is to hold SCE's PPHs during the week of September 29 to October 1. SCE notes that this week is outside of the period given by Your Honors in the e-ruling (August and early September). The week of September 29 is also inconvenient for SCE insofar as it overlaps directly with the already short period of time allotted for preparing rebuttal testimony. Nonetheless, given the intervenors' consensus, if Your Honors are agreeable to hosting the PPHs during the week of September 29, SCE will accommodate the request.

With respect to locations, all parties agree that San Bernardino and Temple City are appropriate, as they represent hot and coastal regions of SCE's territory, respectfully. However, should the Commission elect to hold only two PPHs in SCE's territory, TURN supports swapping San Bernardino with Lancaster (another hot region) because it states that Antelope Valley has never hosted a PPH despite interest from a diverse population of ratepayers in rate reform. SCE believes that two PPHs are sufficient--one in a coastal region and one in a hotter region--and would like Your Honors to choose San Bernardino over Lancaster for the following reasons. First, San Bernardino is more easily accessible to the ALJs because of its proximity to the Ontario airport. San Bernardino also has the added benefit of being located in a more densely populated area (which one hopes will lead to higher attendance). San Bernardino also has a higher penetration of CARE customers than Lancaster does, and it is home to a diverse population of ratepayers.

Thank you for considering SCE's request. Should Your Honors order that bill inserts be used to notify customers about the PPHs, we will need at least 60 days' lead time. However, if notice is to be effectuated via newspapers and public posting, the lead time would be significantly

less (about half that time).

(1) Joint Motion for Modification of Scope and Schedule.

The Joint Motion of San Diego Gas & Electric Company, Southern California Edison Company and Pacific Gas and Electric Company for Modification of Phase 1 Scope and Schedule is denied.

(2) Procedural Schedule.

The Phase 1 Procedural Schedule is modified as follows. If the schedule for Evidentiary Hearings is significantly changed we will consider modifying the due dates for briefs.

- Supplemental Utility Testimony, served May 16, 2014
- IOU Optional Additional Testimony, served **JUNE 30, 2014**
- Intervenor Opening Testimony, served September 15, 2014
- Rebuttal Testimony, served **OCTOBER 8, 2014**
- Evidentiary Hearings November 3- 21, 2014
- Opening Briefs, filed **DECEMBER 8, 2014**
- Reply Briefs, filed **JANUARY 5, 2015**

(3) Public Participation Hearings.

The utilities will work with the intervenors to create a list of suggested locations for Public Participation Hearings. **The list is due on May 23, 2014.** The list may include suggested dates in August or early September 2014. At the PHC, parties indicated that five Public Participation Hearings are necessary as follows:

- PG&E territory – 2
- SCE territory – 2
- SDG&E – 1

Additional suggested locations should be included if there is a critical need.
