As part of CPUC's continued commitment to safety, I am pleased to introduce the addition of the Safety Office under Administrative Services, Management Services Branch. This office will support the CPUC's efforts in reorienting employees towards building a better safety behavior and complement the CPUC's Executive Safety Council. The Executive Safety Council is comprised of CPUC Division Directors and Commissioners' Chiefs of Staff. Its overall purpose is to provide a leadership role to incorporate safety in all that we do. This includes both internal and external issues and the impacts on employees and the utilities we regulate. The Safety Office will be responsible for ensuring overall safety of the workplace in all CPUC locations and the CPUC's compliance with all local, state, and federal regulations such as OSHA, DOT, and the EPA. The office is comprised of two new Safety Officers, <u>Amanda</u> Hult and Adé Sogbesan.

Some of the essential responsibilities of the Safety Officers are to accomplish safety compliance by coordinating, administering, and implementing comprehensive training programs in occupational, industrial, and environmental safety to all employees before they are put at risk in their work environment. Other duties include providing CPUC-wide awareness in all areas of safety and health hazards, performing routine safety and environmental audits, effective record-keeping of accidents, injuries, illnesses, and incidents, communicating safety information CPUC-wide, screening sub-contractor safety information for project procurement, and stressing the key components of safety leadership within management. A more detailed description of the new Safety Office is under construction and should be available soon.

Now a little history about our new Safety Officers:

Amanda has been with the CPUC for more than six years and she has made a shift in her career at the CPUC, leaving the Training Office and moving into the Safety Office at the CPUC. Amanda is one of two Safety Officers at the CPUC and in her new role will focus on building up the employee safety programs.
