Per your request:

The event referred to below was a third party dig-in on a 2-inch plastic service line at the Presidio. The GC supervisor at the scene indicated that the excavator had a valid USA ticket and that the facilities were located and marked. Locate and Mark personnel did as best as they could with the information on hand and the excavator took appropriate precautions to hand dig in the area delineated. The service that was hit was part of the old, army installed facilities that PG&E inherited and is in the process of upgrading. Some of these facilities do not have locating wire and the army maps are not always complete or accurate. In this case the locating wire had been damaged so the service was not locatable. The locating wire was repaired and maps are being updated with the most accurate information.
