Per the kick-off meeting on April 30, 2014 at PG&E's [Redacted] it was agreed that these items should also be included as evidence if discovered during the demolition:

1. Geotech Fabric (used for wrapping charged structural columns)
2. Chain Link (used for wrapping charged structural columns)
3. Boiler Castable Refractory from furnace water walls (remove a sample from the furnace waterwall)

It was mentioned in this meeting that all asbestos mitigation work has been completed, however, please submit test documentation and/or asbestos mitigation reports that confirm that the castable refractory used in the PG&E [Redacted] water-wall section of the furnace are free of asbestos. Please submit this no later than May 7, 2014.
