Pursuant to Rules 11.1 and 11.4 of the Rules of Practice and Procedure of the California Public Utilities Commission ("Commission" or "CPUC"), John Lathrop respectfully files this Motion for Leave to File Confidential Personal Financial Information ("Confidential Information") Under Seal ("Motion"). John Lathrop moves the Commission for an order granting leave to file the Confidential Information, as called for by Ordering Paragraph 1 (re Principle 10 of Appendix A) of Decision 98-04-059, under seal.

This Motion is made pursuant to Public Utilities Code Sections 1802(g) and 1804(B), and further supported by General Order 66-C Section 2.2. Making that Confidential Information generally available for public disclosure would unnecessarily intrude on John Lathrop's privacy. Therefore, that Confidential Information must be protected. That Confidential Information will be redacted from the public version of the Notice of Intent to Claim Intervenor Compensation that will be filed imminently by John Lathrop.

ADMINISTRATIVE LAW JUDGE'S [PROPOSED] RULING ON JOHN LATHROP'S MOTION FOR LEAVE TO FILE CONFIDENTIAL PERSONAL FINANCIAL INFORMATION, AS CALLED FOR BY ORDERING PARAGRAPH 1 (RE PRINCIPLE 10 OF APPENDIX A) OF DECISION 98-04-059, AND FURTHER SUPPORTED BY GENERAL ORDER 66-C SECTION 2.2, UNDER SEAL

On May 25, 2014, John Lathrop filed a Motion for Leave to File Confidential Personal Financial Information Under Seal ("Motion"), as part of his Notice of Intent to Claim Intervenor Compensation, seeking an order granting leave to file his personal financial information ("Confidential Information") under seal. In accordance with the California Public Utilities Commission's ("Commission") Rules of Practice and Procedure, the Commission has considered John Lathrop's Motion. This ruling grants John Lathrop's Motion.

Accordingly, it is ORDERED that:

1. John Lathrop's Motion is granted. The Confidential Information (as defined in the Motion) is protected by Decision 98-04-059, General Order 66-C Section 2.2 and Public Utilities Code Section 1804(B).

2. Public disclosure of the Confidential Information would constitute an undue and unnecessary violation of John Lathrop's privacy. As maintained in GO 66-C Section 2.2, making it generally available for public disclosure would unnecessarily intrude on John Lathrop's privacy. Therefore, that Confidential Information must be protected.

3. The Confidential Information, which has been submitted under seal, shall remain under seal and shall not be made accessible to or disclosed to anyone other than Commission staff except pursuant to protective order or on the further order or ruling of the Commission, the assigned Administrative Law Judge ("ALJ") or the ALJ then designated as Law and Motion Judge.

4. John Lathrop shall file a public version of the filing with the Confidential Information redacted.
