# Rulemaking 13-09-011 to Enhance the Role of Demand Response Workshop and Evidentiary Hearing Information and Schedule June 9-13,2014

As was determined in the May 30, 2014 Administrative Law Judge Ruling, the five days of hearings previously scheduled in Rulemaking (R.) 13-09-011 has now been separated into two days of workshops and two plus days of evidentiary hearings.

The May 30, 2014 Ruling provided only two days of evidentiary hearings. After review of the cross examination estimates provided by parties on June 2, 2014, the schedule has been expanded to two and a half days of hearings. Past experience has shown that cross examination estimates are sometimes over-estimated, thus the times for cross examination have been decreased. Furthermore, witnesses scheduled for early Thursday should be prepared to take the stand on Wednesday afternoon if the schedule proceeds quicker, unless a witness requested a specific date to be cross examined. Similarly, witnesses for Friday should be available on Thursday if the hearings proceed at a quick pace. The hearing schedule will also be reevaluated on Tuesday afternoon following the two days of workshops. As requested by San Diego Gas and Electric Company and agreed to by the parties cross examining, Witness Avery will be cross examined early on Monday morning prior to the commencement of workshops.

The point of the workshops is to attempt to develop consensus between opposing sides or develop a better understanding of the opposing sides with respect to the issues discussed. Thus, the workshops will entail "roll your sleeves up" discussions with few presentations. Parties wanting to provide CAISO market integration costs presentations will be permitted. However, as was directed in the May 30, 2014 ruling, parties wanting to provide integration cost presentations shall request to do so by June 4, 2014.

At this time, the revisions in the cost-effectiveness protocols have been delayed to a later date. Parties will receive information at a later date regarding the schedule for determining the issues regarding this subject.

Lastly, Pacific Gas and Electric Company, San Diego Gas & Electric Company, and Southern California Edison Company have been directed to take notes and develop a draft workshop report to be filed by the three utilities in this proceeding (as a draft) on June 19, 2014. Comments and reply comments to the draft report will be filed by the parties on June 26, 2014 and July 3, 2014, respectively.
