I believe that next week's workshops are intended to determine if the parties can reach agreement on issues that are currently in contention, possibly by making compromises. However, I believe that the workshops are not being held under Rule 12.1 of the Commission's Rules of Practice and Procedure. The utilities will also be preparing a workshop report, which will go into the record after review and comment by others. For these reasons, my assumption is that nothing said in the workshops will be confidential, and statements could be used elsewhere. If I am not correct in my assumptions, please let me know.

I will be serving this e-mail on the parties separately, because if I just send an e-mail response to a lengthy service list, the message becomes garbled.
