Ordering Paragraph 2: Within 30 days from the issuance of this decision Pacific Gas and Electric Company, San Diego Gas & Electric Company and Southern California Edison Company (jointly, the Utilities) shall organize and meet with the appropriate Commission Staff, the Office of Ratepayer Advocates, and any other interested stakeholders to develop an agreed-upon reporting template for providing weekly exception reporting, using the draft reporting template in Attachment A as a starting point. All stakeholders should take into consideration other utility reporting requirements to ensure no unnecessary duplication. The required reporting shall include parameters to ensure the confidentiality of protected data. Within 30 days following the initial meeting, the Utilities shall file a Tier Two Advice Letter requesting approval by the Commission of the final reporting template.
