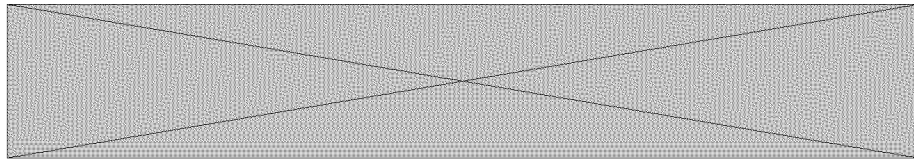

Dear Ms. Chow & Mr. Randolph:

I am writing on behalf of the Center for Energy Efficiency and Renewable Technologies (CEERT) to request additional time to submit comments to you on SDG&E's LTPP/Track 4 Procurement Plan (Conventional Procurement) and LTPP/Track 4 Procurement Plan (Preferred Resources). These plans were only noticed yesterday to the R.12-03-014 (LTPP) service list by your email below, yet you have set a comment due date that will give parties only 5 business days to review these plans and prepare comments in response. In addition, the assigned ALJ to the same LTPP proceeding at issue (R.12-03-014) has set June 23 as the date on which responses are due on a Petition for Modification requesting public dissemination and comment on these plans.
