To All Parties on Service List No. R. 13-09-011:

Please find attached the Amended Opening Testimony of Environmental Defense Fund on Phase Two and Phase Three Issues, in PDF/A format. The amendments are as follows:

- 1) On page 11, line 8, the word "one" is replaced with the word "three."
- 2) On pages 17 to 18, the following sentences are added: " It should also be stressed that some DR resources can be categorized either as load-modifying or supply in the CPUC bifurcation. This is true of several resources listed in the Categorization table, including the SmartAC Cycling DR program, which can be called on at the substation level. For example, SmartAC could be seen as load modifying especially with respect to its hard to measure potential lingering conservation effects (e.g., a participant opens window during AC Cycling DR event to discover a strong cross breeze, resulting in a persistent behavioral change of window opening instead of AC usage.) "
