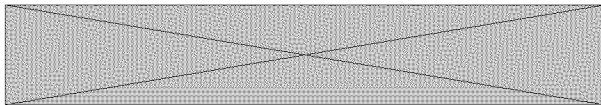
Dear Judge Hymes,
