The California Municipal Utilities Association (CMUA) has published a Technical Reference Manual (TRM) for the California municipal utilities.

The savings estimation technical reference manual describes – for program administrators, regulatory agencies, program evaluators, utility customers, and other interested stakeholders – how California publicly owned utilities consistently, reliably, and transparently calculate energy savings for their energy efficiency programs.

The reference manual provides the methods, formulas, and default assumptions used for estimating energy savings and peak demand impacts from energy efficiency measures and projects. The energy savings estimates are used to report program accomplishments and measure progress towards program goals
