As you may be aware, SED has been tasked by the presiding judge to prepare a report on PG&E's GT&S GRC filing. One major portion of the report will be to examine, as stated in the GT&S GRC proceeding scoping memo, "the risk assessment approach that PG&E employs in this application. This risk assessment approach is part of the basis upon which PG&E developed its costs for this proceeding."

I have just been delegated the responsibility to prepare the evaluation of the risk assessment approach portion of the report and will need to gather information on the risk methodology from PG&E within the next couple of weeks. I've attended several meetings with PG&E representatives where high level presentations of the risk methodologies were presented. I would like to get below the high level presentations and drill down into the details in order to fully understand how risk-based decision making was incorporated into the current GT&S GRC.

I envision a series of meetings with PG&E within the next 2 weeks to accomplish this task.
