**Reps. Anna G. Eshoo (D-Calif.), Ben Ray Luján (D-N.M.), Don Young (R-Alaska) and Tom Cole (R-Okla.)** sent a [letter](#) to the Government Accountability Office on June 18, 2014, to ask that it study the current state of communications services on Tribal lands. They noted that based on the most recent available data, over 30 percent of households on Tribal lands still lack basic phone service and less than 10 percent of residents on Tribal lands have broadband access.
