**CPUC TO HOST THOUGHT LEADERS EVENT ON  
CALIFORNIA AND GERMANY ENERGY POLICIES**

SAN FRANCISCO, May 6, 2014 -- The California Public Utilities Commission (CPUC) today announced that its next "Thought Leaders Speaker Series" will feature a comparison between the energy and environmental policies of California and Germany. This informative discussion is free and open to the public.

**WHEN:** June 5, 2014, 1:30 p.m. - 3:30 p.m.

**WHERE:** CPUC Auditorium, 505 Van Ness Ave., San Francisco; also available in real-time

and archived via video webcast at [www.californiaadmin.com/cpuc.shtml](http://www.californiaadmin.com/cpuc.shtml).

**WHAT:** A discussion of California's energy policies versus that of Germany, including Germany's Energy Transformation (Energiewende); California and Germany electricity costs; the push for renewable energy; and whether the utility business model is changing in either country. There will be a 45-minute audience-driven question and answer session following the discussion.

Panelists:

- **Graham Weale** – Mr. Weale is the Chief Economist for RWE AG (one of the two largest German power companies) in the Essen Headquarter office. In this capacity, along with responsibility for the company planning assumptions and forecasts, he has led major studies on subjects such as the impact of the Energiewende, the consequences of the Euro-crisis, and the outlook for decentralized generation. Previously he was Director of European Energy Services for Global Insight (now part of IHS CERA) where he undertook projects for energy companies throughout Europe, the European Commission, European governments and regulators, and acted as an expert witness on a number of high profile gas arbitration cases. Prior, he worked as a management consultant with Deloitte specializing in energy liberalization issues.

- **Fong Wan** – Mr. Wan is the Senior Vice President of Energy Procurement for Pacific Gas and Electric Company (PG&E), and is responsible for gas and electric supply planning and policies, market assessment and quantitative analysis, supply development, and procurement and settlement. Mr. Wan joined PG&E in 1988 as a financial analyst and spent six years in the Financial Planning and Analysis organization. He then worked in the Gas Supply and Electric Transmission business units before moving to PG&E Energy Trading in 1997. He served for four years as Vice President, Risk Initiatives for PG&E Corporation Support Services, Inc., and was named Vice President, Power Contracts and Electric Resource Development at PG&E in May 2004. He became Vice President, Energy Procurement, in January 2006 and was named to his current position in October 2008.
