## Ken

I'm glad I was able to reach you this morning and am also looking forward to Monday's call with Sumeet and Sean Kolassa.

Just to recap:

As of today we are standing down all non-emergency plastic fusion work in light of our recent realization that we have a compliance gap in the way we have been conducting annual employee requalifications associated with plastic fusion.

The gap applies to **re**-qualification of PG&E employees, and we are now putting a plan together to make sure the full testing (both visual inspection and destructive testing) has been appropriately completed.

We have an established procedure to respond to any emergency work including fully qualified staff.

We plan to submit a self-report on this non-compliance issue no later than July 7.

As we discussed, this gap in our employee requalification process does not raise safety concerns about any of the work that has been completed in the field. Every plastic pipe installation is tested onsite with a pressure and soap test before being placed in service.
