Thank you for taking the initiative and time to meet with us yesterday, Tuesday the 24th. I am encouraged by the open dialog and spirit of cooperation.

I am impressed by the efforts already made and I especially appreciate the expressed priority given to safety by the suspension of tram usage for human transportation. I am sure the suspension will increase the desire for an immediate correction of the remaining issues.

As agreed, I look forward to the resolution of the items numbered 7, 8, 13, 14, 15 and 16 and hope you can have a corrective action plan with a timeline of implementation available by July 31, 2014. I will write a formal letter to

this effect by COB Friday the 27th. If I am mistaken, made an omission or if you need more time please contact me immediately.

I understand and appreciate the complexity of updating and designing new safety procedures and safety measures. In the spirit of cooperation; if it helps, the design process can be part of the corrective action plan as long as it is followed by a date of implementation. For example,

- 1.Establishing Criteria for the braking system*; to be completed by (date).*
- 2.Hiring Consultants and do research; to be completed by (date).
- 3.Brainstorming solutions; to be completed by (date).
- 4.Design and drawings; to be completed by (date).
- 5.Building and/or Installation; to be completed by (date).
