Parties of Service List R11-05-005:

Based on conversations with retail sellers to provide edits to the RNS template, please find the revised (v2) version of the RNS template attached. All the changes made to the original template are highlighted in yellow.

The following changes have been made:

1. Delete row for “*RECs pending CPUC approval*” (formerly **Fd**) – to avoid double-counting RECs pending approval in lines Fa/Fb/Fd
  - a. This also changed the calculation of row (**F**) to  $(Fa+Fb+Fc-Fd)$
2. Change the formula of (**La**) to  $(Ga + Ia - Ib - Hc)$  – to avoid double-counting bank carried over from (Ga)
3. Change the formula of (**Lb**) to  $(F + Ia - Ib - Hc)/A$  – to reflect change #2
4. Values in row (**B**) will be rounded off to the nearest .1% to maintain consistency with the compliance report formatting
5. The forecast year row will be left blank so that the cells can be manually be updated by the retail seller on a year-by-year basis.
