E-MAIL RULING REQUIRING ADDITIONAL SUPPLEMENTARY TESTIMONY

The Third Amended Scoping Memo and Ruling of Assigned Commissioner was issued on April 15, 2014 (April 15 Ruling). The April 15 Ruling required the three large utilities to answer certain questions by no later than May 16, 2014. The three large utilities served their Additional Supplementary Testimony on that date.

Review of the served Additional Supplementary Testimony reveals that some of the answers were not sufficiently responsive to the April 15 Ruling. We therefore direct

PG&E and SDG&E to serve sufficiently responsive answers as follows.

1. SDG&E is directed to answer the following question from the April 15 Ruling by no later than July 23, 2014:

(5) Energy Efficiency, Demand Response and Distributed Generation Programs:

d. Estimate total load reduction and peak period reduction or load shifting using the "Conservation Tab" of the PG&E RROIR Bill Impact Calculator or an equivalent tool. Use an appropriate elasticity assumption and justify and explain your choice of elasticity assumption.

2. PG&E is directed to answer the following question from the April 15 Ruling by no later than July 23, 2014:

(6) NEM Bill Impacts:

a. Provide bill impact data for NEM customers for all of the proposed rate options over the 2015-17 transition period.
