To Parties in A.13-12-012 (PG&E's Proposing Cost of Service and Rates for Gas Transmission and Storage for 2015-17):

As directed by the Assigned Commissioner's Scoping Memo, the Commission's Safety and Enforcement Division is preparing a report on Pacific Gas & Electric's risk assessment approach as it relates to this proceeding. Commission Staff intends to issue a draft report on July 18, 2014 and will be hosting a workshop on Wednesday, July 30th. The purpose of the workshop will be to discuss the draft report, including technical questions, criticisms and clarifications. The workshop will be held in San Francisco at the CPUC Headquarters, 505 Van Ness Avenue in the Golden Gate Room. An agenda for the workshop will be distributed to the service list in advance. After the SED workshop, Commission Staff will prepare a final version of the SED Report based, in part, on the parties, comments during the workshop.

In consultation with the Assigned Office, Commission Staff is timing both the distribution of the draft SED report (on July 18th) and the SED workshop (on July 30th) to occur before ORA and Intervenor's Testimony is due on August 11th, 2014 and concurrent Rebuttal Testimony on September 15, 2014.
