I have talked with the Gas Ops team about this issue and can confirm that we have not previously heard the concerns referenced below about deficiencies in our gas cross bore review program. We refer to that as our “legacy cross-bore inspection” program.

Raymond Thierry, Director of Distribution Integrity Management, will be our lead contact for your team as you move to review this program. His contact information is [Raymond.thierry@pge.com](mailto:Raymond.thierry@pge.com) (and he's copied on this email obviously), phone is 925.328.5936.

Raymond reports to Sumeet Singh, VP of Asset and Risk Management.

We have a great deal of information about cross-bores and what we are doing to address them, both on the legacy side and from the perspective of what we are doing now to reduce risk in current work through new processes and tools. The attached high level overview has previously been provided to SED and representatives of the City of San Francisco, and it may be helpful in providing context around this issue in the gas industry generally and PG&E specifically.

I assume your assigned investigator will be in touch with Raymond soon so they will can get clarity around the scope of the investigation and the types of information that will best support it.

We look forward to working with you to resolve these concerns quickly.

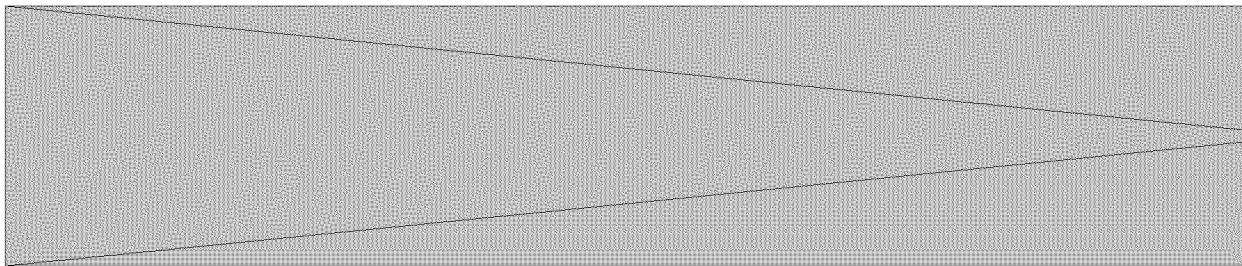
