An Open Letter to DGS, our Building Manager, and to whom it may concern:

I am writing this letter in response to the email dated July 11th at 4:54 PM that effectively changes the bicycle storage policy at the CPUC building beginning on July 21st. This email in two words basically states that this new policy is being enacted for "safety purposes." However, this email does not elaborate further on any specific safety codes or building codes that have been violated through the storage of bicycles in workspaces, aisles, or cubicles areas of the building. I can personally testify that I store my bicycle in an empty cubicle that is well out of the way of any common area. I can also avow that fellow bicyclists make every effort to not obstruct pathways or common areas of the building with their own bicycles. Without evidence that the current bicycle storage policy is causing safety hazards, this email is baseless and unfounded.

This email then goes on to direct all employees to park their bicycles in locations that have proven to be unsafe at the bike racks in the courtyard and the garage. Both of these locations are known hazards as bikes and bike parts have been stolen while being parked at these facilities. The only other location that is given as an option in this email is the bike room located in the P1C-5 area. Although there has been much thought and effort put into the creation of this bike room, this room is currently at half capacity with 24 wall hooks and 10-12 being used daily. This usage only reflects the current policy where there are bicyclists that do not use this room, who store their bicycles near their workspaces and who store their bicycles at 455 Golden Gate because they are currently located there. Unfortunately, the launch of this bike room coincided with the Restack Project, so the capacity has not been fully tested by the entire number of CPUC bicyclists. With the proposed policy, this room may very well be stressed to its limits with the storage of bicycles at its full capacity leaving little room to maneuver around and may in fact create unsafe conditions within the room itself

At a time when this Commission has a renewed focus on safety, we still should not lose sight of due process. This email lays out a fundamental shift in policy on bicycle storage and dictates this policy go into effect 10 calendar days after service of this email. As policymakers here at the Commission, we are bound by the PU Code and the Rules of Practice and Procedure when effecting change. For example, comments on proposed decisions must be filed within 20 days of the date of service. With this email, only questions and concerns about the new policy may be levied within the 10 days allotted. Here, we must ask whether we received our due process or are we simply being dictated to in a totalitarian state? Even the utilities we regulate are required to give proper notice and hold public hearings for any rate increases, but with this email, our voices are not given the opportunity to be heard. I just ask now that we have an open dialogue of this policy change before it is enacted or else how can we really practice what we preach here at the Commission?

Subject: BICYCLE STORAGE

For safety purposes bicycles are not to be stored in the workspace, aisle/hallway or cubicle area of the building.

Beginning July 21, 2014, the building security personnel will deny access to any employee, contractor, or intern attempting to carry a bicycle onto the main lobby elevators or into the main stairwells. Security will redirect staff to the bike racks, located in the Courtyard, Golden Gate entrance; on level P1 of the garage; and to the bike room, located in the P1C-5 area, across from the former daycare center office.

To use the bike room, employees must email CPUC Facilities at cpuc.ca.gov to get the access code for the door lock.

These areas are to be used for day parking of bicycles only, no overnight storage. They are available on a first-come, first-serve basis.
