It is probably worth mentioning that the reason the bike rack is disassembled is because during the most recent bike theft from the parking lot bike racks, the thief disassembled the bike rack (as shown in the attached photo) and then slipped the locked bike off of the rack. If DGS simply reassembles the rack, it and the other rack will still be prone to additional future thefts. What would be much more helpful would be for DGS to reassemble with heavy-duty tamper-proof screws and do the same for each of the other ends of the two bike racks. Until that is done, bikes locked to the ends of the bike racks will be prone to theft. As Amanda mentions, locking bikes to the middle of the rack is safer.

Another option would be to replace the current racks (designed for children-sized bikes) with more modern and adult-sized bike racks.
