To confirm our phone conversation within the hour:

- 1. We acknowledge the letter you sent this afternoon about your concerns with our plastic fusion requalification procedures as we reported to you yesterday in our self-identified non-compliance notification under ALJ 274.
- 2. We are taking immediate steps to address the two items you identified. Specifically, we are immediately standing down all non-emergency plastic fusion work and will be notifying all gas employees of this action early tomorrow morning.
- 3. Tomorrow, as soon as scheduling allows, we also are convening a team to deconstruct our training/requalification process and procedures and obtain clarity and alignment on each step of the process in great detail so we are in full and absolute compliance with 49 CFR 192.285. We will pull together the independent third party reviewers we have retained, as well as the internal management team overseeing this process. As we discussed, we would very much appreciate SED participation in that planning meeting if at all possible. You indicated you would attempt to provide someone on your team, or possibly even you, once we are able to give you details of time and place. Sumeet will provide that information later this evening.
