On July 28, 2014, Pacific Gas and Electric Company (PG&E) filed “Motion of Pacific Gas and Electric Company for Permission to File a Preliminary Response to the City of San Bruno’s Motions.” The City of San Bruno filed its response to the motion on July 29, 2014.

The Commission’s Rules of Practice and Procedure do not provide for the filing of a “preliminary response” to a motion. PG&E has failed to provide justification why an exception should be granted. Therefore, PG&E’s motion is denied.
