Attention: All retail sellers that submit compliance reports pursuant to the California Renewables Portfolio Standard (RPS) program and California RPS program stakeholders

All California retail sellers must submit a preliminary 2013 Annual 33% RPS Compliance Report using the reporting format provided by Energy Division staff, no later than August 1, 2014, pursuant to Decision (D.) 12-06-038. Detailed instructions for the qualitative and quantitative reporting requirements are outlined in the Instruction tab of the preliminary Annual RPS Compliance spreadsheet. The preliminary Annual RPS Compliance spreadsheet is available on the Commission's RPS website:

Additionally, staff would like to remind all retail sellers that WREGIS reports must be filed with Energy Division and the CEC no later than July 1, 2014. For additional information please see the CEC guidebook (available here: <http://www.energy.ca.gov/2013publications/CEC-300-2013-005/CEC-300-2013-005-ED7-SF.pdf>). Retail sellers are not required to file any additional information (other than their WREGIS reports) to substantiate their PCC classification claims at this time.

If you have any questions regarding the spreadsheet and/or the RPS compliance process staff highly encourage you to contact Energy Division prior to Friday, June 20. Energy Division staff will have limited availability to answer stakeholder questions regarding the compliance report spreadsheets from June 23 until July 21.
