CPUC judges to issue proposal for fine against PG&E in San Bruno case

State regulatory judges are expected to issue a proposal during August or September for the fines and punishments that PG&E should receive in connection with its role in the fatal explosion of a natural gas pipeline in San Bruno nearly four years ago, according to an official notice posted Thursday.

San Francisco-based PG&E faces a fine from the state Public Utilities Commission of up to \$2.25 billion in connection with the San Bruno explosion in September 2010.

The proposed ruling on the fine would be issued by a pair of administrative law judges who have been evaluating testimony about the matter. The ruling could come as soon as this week, but must be issued within 60 days.

After the judges issue their proposed ruling, the full PUC will consider the matter, a ruling that could come before the end of this year.
