TO: PARTIES TO DRAFT RESOLUTION E-4628

Enclosed is Draft Resolution E-4628 of the Energy Division addressing Pacific Gas and Electric Company's AL 4292-E. Comments shall be limited to five pages in length plus a subject index listing the recommended changes to the Draft Resolution and an appendix setting forth the proposed findings and ordering paragraphs.

Comments shall focus on factual, legal or technical errors in the proposed Draft Resolution. Comments that merely reargue positions taken in the advice letter or protests will be accorded no weight and are not to be submitted.
