Hi Lisa-Marie -

Assuming the settlement conference is going to be held at the utility's premises, you may accept the lunch meal up to a \$15 value, as long as the total value of food/beverage you receive does not exceed \$30 in any given month or \$360 in a calendar year. See our Proposed Statement of Incompatible Activities (June 2005), section 9(b)(2). This \$15 on-premises light meal is an exception to the general rule prohibiting CPUC staff from accepting any gifts (regardless of value) from any entity subject to the CPUC's jurisdiction. See Proposed Statement, section 9(a).

With regard to reporting the gift/s under the Political Reform Act, you must report all gifts from the utility totaling \$50 or more on your Form 700 for 2014. To the extent you have already accepted \$50 in meals/gifts from the utility so far in 2014, be aware that, if this meal is accepted, you will have to report ALL gifts from the utility received in 2014. To avoid this reporting requirement, you should consider not accepting the meal or reimbursing the utility for the value of the meal. Under the PRA, you have 30 days from the receipt of the gift to reimburse the donor.

In terms of valuation, pls ask the utility to provide you with a statement showing the value of the meal accepted. And if you reimburse the utility, pls ask for a receipt.
