For each quarter, starting with the second quarter of 2014, please provide SED within 30 days of the end of the quarter, a summary report of activities your company has engaged in to minimize vegetation contact related fires. The report you provide should, at a minimum, demonstrate compliance with vegetation management standards required by the Commission, FERC and CalFire. Examples of data you provide in the report are inspection and patrol aggregate data, quality assurance/quality control work summaries and remedial action plans and activities. Our intent is to give each utility the ability to customize the report based on its unique operations and vegetation management practices with the overall goal of giving SED a snapshot of the activities and the opportunity to investigate specific areas further if necessary.
