One clarification question: For 2014 “actuals” are you looking for year-to-date or can we leave that column blank since we don’t have 2014 actuals yet?

Also, indirect “actual” costs are really just an updated/improved forecast since these costs cannot be precisely determined. I realize that we all know this, but there is still some sensitivity around using the term “actual” here. I would suggest relabeling that column or footnoting it so that others not as familiar with the issue don’t get confused.

I’ll pass this along to my team and let you know if they have any other questions or concerns.
