NOTICE OF EX PARTE COMMUNICATION

Pursuant to Rule 8.4 of the California Public Utilities Commission (“Commission”) Rules of Practice and Procedure, the Alliance for Nuclear Responsibility (“A4NR”) hereby provides notice of the following oral and written ex parte communications:

On August 5, 2014, at 3:49 p.m. I telephoned Sepideh Khosrowjah, chief of staff to Commissioner Michel Florio, and had an approximately five-minute conversation with her concerning A4NR’s Opening Comments on the Proposed Decision. Ms. Khosrowjah initiated the communication with an email to me.
