#### **ALLIANCE OF AUTOMOBILE MANUFACTURERS MOTION FOR PARTY STATUS**

In accordance with Rules 1.4 and 11.1 of the California Public Utilities Commission ("Commission") Rules of Practice and Procedure, the Alliance of Automobile Manufacturers (hereafter, "Alliance") respectfully requests party status in the Order Instituting Rulemaking to Consider Alternative-Fueled Vehicle Programs, Tariffs, and Policies (R.13-11-007).

#### I. Request for Party Status

The Alliance has an interest in matters related to the Rulemaking (R.13-11-007) opened by the Commission to address issues relating to the expanding use of alternative-fueled vehicles (AFV) in California. The Alliance is a trade association of twelve (12) car and light truck manufacturers (BMW Group, Chrysler Group LLC, Ford Motor Company, General Motors, Jaguar Land Rover, Mazda, Mercedes-Benz USA, Mitsubishi Motors, Porsche, Toyota, Volkswagen, and Volvo) offering new vehicles in California.
