Attached to this e-mail, please find PDF versions of the Clean copies of Errata to two chapters of ORA's Direct Testimony, Chapter 10 and Chapter 17, and red-line versions in Word of the same Errata Chapters. ORA found an input error in our RO Model that does not change the total revenue requirement ORA recommended, but does impact allocation and thus does change most of the recommended rates and impacts of those rates on customers. The details of the input error are contained in Chapter 17.

ORA will update its summary chapter, Ch. 1, to conform with these changes sometime in the

very near future. ORA will also provide PDF versions of the redlined Errata chapters to replace the Word versions at some point in the near future.
