TO ALL PARTIES:

The purpose of this [supplemental testimony] is to update PG&E's rate proposal to incorporate changes in rate design resulting from D.14-06-029 in Phase 2 of this proceeding. In its February 28, 2014 prepared testimony, PG&E presented a proposed trajectory of rates for 2014-2018 for its base case, assuming a 2.1 percent year-to-year growth in residential revenues. Since none of the proposed rate trajectories presented in PG&E's February 28, 2014, testimony were based upon baseline quantities set at 52.5 percent of historical usage, they are now outdated and require updating. PG&E has developed updated rates, which it presents in the [supplemental testimony], reflecting the new 52.5 percent baseline quantities that went into effect August 1, 2014. These new rate trajectories also use Commission-approved August 1, 2014, rates as a starting point for the updated rate trajectories. Other than those two changes, all elements of PG&E's February 28, 2014, rate proposal and prepared testimony remain the same.
