During each of the meetings, the PG&E representatives discussed the matters on the handout (attached), labeled “PG&E’s Recommended Changes to 2014 GRC Proposed Decision, August 4, 2014.” These matters concern (i) the interpretation of Senate Bill 705, (ii) three gas safety initiatives denied or reduced by the Proposed Decision, (iii) certain electric safety and reliability initiatives reduced by the Proposed Decision, and (iv) the ratemaking treatment of nuclear fuel. The PG&E representatives also distributed a table (also attached) summarizing the financial impact of PG&E’s recommended changes, which appeared in PG&E’s July 8, 2014 Opening Comments on the Proposed Decision, page SOR-3.
