Contemporaneously with the filing of this Notice of Availability, Pacific Gas and Electric Company ("PG&E") is filing with the California Public Utilities Commission ("Commission")

PG&E's Update to its 2014 Draft Renewable Energy Procurement Plan ("Update"). The 2014

Draft Renewable Energy Procurement Plan ("Draft 2014 Plan") was originally filed in this docket on June 4, 2014, and PG&E filed a motion to amend the Draft 2014 Plan on June 23, 2014. The Update filed today provides revised versions of the Renewable Net Short calculations and the Draft 2014 RPS Form Power Purchase Agreement, both of which were originally appended to the Draft 2014 Plan. The cover pleading filed with the Update provides additional information regarding these changes.

PG&E is filing the Update in compliance with the Assigned Commissioner's Ruling Identifying Issues and Schedule of Review for 2014 Renewables Portfolio Standard Procurement Plans, issued in this docket on March 26, 2014 (the "ACR"). 1/2

In an e-mail dated April 16, 2014 to the service list for this proceeding, Administrative Law Judge ("ALJ") DeAngelis granted a joint investor-owned utility ("IOU") request for an extension of three weeks to the schedule set forth in the ACR. Accordingly, updates to the draft 2014 RPS Plans are to be filed not later than August 20, 2014.

The Update significantly exceeds 50 pages. It will be posted on August 20, 2014 on PG&E's website in a readable, downloadable, printable, and searchable format.
