<b>REMINDER: Between now and midnight 8/31, trades can only be made between teams contiguous in the preceding week's standing. Trades made after 12:01 PM 8/26 through midnight 8/31, will be effective 9/2. No trades are permitted from 9/1 through the end of the season. Also, please see Article XVI, September Roster Expansion (SRE). The fee for expanding rosters is \$25 per player and salary of players from the free agent pool is \$25. The salary of a SRE callup from a team's reserve list or farm system is the salary established at the time he was previously acquired. Also, the In-Season Salary Cap increases to \$400 beginning 9/1.</b>													
<b>During the 24-hour period on 9/1, SRE claims take precedence over waiver claims and routine callups to replace players. The order of selection is determined by the most recent weekly standings, with the last-place team having first selection, and so on. Transactions on 9/1 will be effective 9/2.</b>
