The presentation will be used at all PPHs, and we anticipate that the Assigned Administrative Law Judge will give the presentation as part of the PPH introduction.

The presentation should contain the following elements and be limited to less than 10 slides.

- Overview of residential rate design changes being considered in this proceeding
- 1 slide for each utility's specific proposal

The draft presentation should be served on the service list no later than September 9, 2014.

In the interest of efficiency, there will not be a formal comment process for the presentation, but we believe parties may wish to see the draft presentation.
