Thank you for putting us on the agenda. I would just like to re-state our mission just for clarification sake.

Our **mission** is to create a tool that can be customized by State Commissions to help them better identify and understand how safe and resilient their utilities really are. This tool will or rather we hope it will lend itself to be used by an independent agency like DOE or think tanks to publish some of the top utilities that have best practices in safety and resiliency.

Why are we doing this? We are doing this because of three reasons. 1) currently

there are no universal standards for safety/resiliency evaluation/analysis; 2) identify cost effective safety & resiliency strategies, and 3) we want to identify and prevent unbounded safety/resiliency utility requests at the expense of consumers.
