Molly,

Yes, we have had frequent communications with Mr. Lubin and made several refinements to our construction and restoration plans as a result of this dialogue. For example, Mr. Lubin was concerned with the 85 foot working strip throughout the project area. We were able to reduce that area in some places to 60 feet in width. Though this eliminates efficiencies, it does reduce the overall ground disturbance. Additionally, we eliminated a planned turnaround area on the northerly side of the pipeline on Caltrans property, and performed some fabrication work offsite which will help reduce the required workspaces at the construction sites. We were also able to shift the alignment slightly around a serpentine rock outcrop Mr. Lubin expressed concern over

PG&E continues its commitment to restore the work areas upon project completion and we are meeting with Mr. Lubin along with the Town of Woodside in person on Thursday to review his comments on our restoration plan.
