Dear Judge Malcolm:

Please find attached our Motion for Determination of Applicability of the California Environmental Quality Act and Request for Hearing and/or to Reschedule the Prehearing Conference for the Sunrise Powerlink Project.

Our motion seeks to clarify how San Diego Gas and Electric Company ("SDG&E") and the Commission intend to comply with the California Environmental Quality Act in light of SDG&E's "Motion to Set Procedures and to Defer Certain Filing Requirements" ("Motion to Defer") and "Application for Certificate of Public Convenience and Necessity" ("Application"). It requests that you permit a reply brief on our motion and that you order a hearing to ensure that critical CEQA and utility law issues are fully and adequately considered.

Our motion also requests that you reschedule the planned January 31st prehearing conference to reasonably ensure that all concerns are at least raised and that protests, motions, and responses are all filed prior to attempting to establish a schedule for hearings and other matters pertaining to SDG&E's Application. In the alternative, we request that you proceed with the January 31st prehearing conference but that you not allow any substantive consideration of SDG&E's motion or any subsequent Commission decision on this matter until the close of briefing and a hearing.

We regret that our motion did not arrive before the Commission formally scheduled its prehearing conference. But we are also surprised that the prehearing conference is scheduled to take place prior to the February 17th close of the extended protest period and period to respond to SDG&E's motions. Nonetheless, we propose the attached briefing and hearing schedule in an effort to help ensure full briefing on these matters before your decisions on schedule and scope.
