

**DECLARATION OF INGER GOODMAN IN SUPPORT OF CLAIMS OF
CONFIDENTIALITY OF COMMERCE ENERGY, INC.**

I, Inger Goodman, declare as follows:

1. I am employed by Commerce Energy, Inc. (“Commerce”) in the position of Regulatory Affairs Specialist.
2. I have reviewed, or caused to be reviewed, the August 1, 2014 RPS Compliance Report of Commerce.
3. The statements in this declaration are based on my knowledge, information, or belief.
4. I am authorized to make this declaration on behalf of Commerce.
5. Those portions of Commerce’s RPS Compliance Report and Commerce’s Request to Make Up its RPS Compliance Period 1 Procurement Quantity Requirement identified in Table 1 below are eligible for confidentiality protection pursuant to Decision (“D.”) 06-06-066 and D.08-04-023 and the Matrix of Allowed Confidential Treatment for Energy Service Provider Data (“ESP Matrix”) attached as Appendix B to the latter decision.
6. The data for which Commerce requests confidentiality and thereby protection from public disclosure are of the types and correspond to the category (or categories) in the ESP Matrix specified below:

Commerce's customers may be harmed by the loss of confidentiality insofar as members of the public not eligible to review the data as non-market participating parties—primarily other market participants such as other ESPs or wholesale suppliers or RPS supplies—can use this data to derive Commerce-specific RPS procurement requirements (net short) and Commerce's current compliance position, particularly in light of the relative scarcity of such resources eligible for the product content category one resources.
