**CONFIDENTIALITY DECLARATION
FOR YEAR 2013 PRELIMINARY ANNUAL 33% RPS COMPLIANCE REPORT

The 2013 Preliminary Annual 33% RPS Compliance Report (“RPS Compliance Report”), which is the subject of this confidentiality declaration, has been submitted to Commission staff, as well as the presiding administrative law judges for the above-captioned proceeding, pursuant to the RPS reporting requirements established in Decision No. (D.) 12-06-038. In addition, a redacted (public) version of the report has been served on the parties to the above-captioned.

Certain information contained in the subject RPS Compliance Report, as specified herein, is eligible for confidentiality treatment under the provisions of D.06-06-066 and the “Matrix of Allowed Confidential Treatment Energy Service Provider (ESP) Data” adopted in the aforesaid decision, as modified by D.08-04-023. Under those decisions, forecasts of retail sales (and information that can derive such forecasts) are allowed to be kept confidential for three forward years, and historical market purchases of energy and capacity are permitted to be kept confidential for one prior year. With these principles in mind, the undersigned declarant hereby verifies that the following RPS-related compliance data¹ is confidential and the Commission is obligated to protect it so as to avoid material harm to Noble Americas Energy Solutions LLC (“Noble Solutions”) and its customers.


