## EXPIRATION DATE AMENDMENT TO STANDARD OFFER #4 POWER PURCHASE AGREEMENT LOG NUMBER 01W146D

This EXPIRATION DATE AMENDMENT TO THE STANDARD OFFER #4 POWER PURCHASE AGREEMENT FOR LONG-TERM ENERGY AND CAPACITY, LOG NUMBER 01W146D ("**Expiration Date Amendment**") is made as of the later signature date below (the "**Effective Date**"), by and among Pacific Gas and Electric Company ("**PG&E**" or "**Buyer**") and Green Ridge Power, LLC ("**GRP**", or "**Seller**"), who are sometimes referred to in this Expiration Date Amendment individually as a "**Party**" and collectively as the "**Parties**."

## **RECITALS**

A. PG&E and Seller's predecessor in interest entered into that certain power purchase agreement ("**PPA**") designated by PG&E Log Number 01W146D for 100 megawatts ("**MW**"), effective as of November 5, 1984 (the "**Agreement**");

B. The Agreement is one of several PPAs entered into by the Parties with respect to electricity generated by wind turbine facilities ("**Windplants**") located in the Altamont Pass Wind Resource Area in Alameda and Contra Costa Counties, California ("**Altamont Pass PPAs**");

C. The Agreement expires on December 31, 2018 and the Altamont Pass PPAs, designated by PG&E Log Numbers 01W018, 01W035, and 16W011 expire on different dates ("Identified Altamont Pass PPAs"); and

D. The Parties now desire that the Identified Altamont Pass PPAs expire on the same date as certain other Altamont Pass PPAs.

NOW, THEREFORE, in consideration of the mutual covenants and agreements set forth in this Expiration Date Amendment, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties hereby agree as follows:

## AGREEMENT

1. <u>Term of Agreement</u>. "ARTICLE 12 <u>TERM OF AGREEMENT</u>" is deleted and replaced by the following text:

"This Agreement shall be binding upon execution and shall terminate on December 31, 2015."

2. <u>Capitalized Terms</u>. Capitalized terms not defined herein shall have the meaning ascribed to them in the Agreement.

3. <u>Effect of Amendment</u>. The Agreement remains in effect in accordance with its terms except to the extent provided herein. If there is any conflict between the Agreement and this Expiration Date Amendment, the Expiration Date Amendment shall control.

4. <u>Governing Law</u>. This Expiration Date Amendment and the rights and duties of the Parties hereunder shall be governed by and construed, enforced and performed in accordance with the laws of the state of California, without regard to principles of conflicts of law. To the extent
