SECOND AMENDMENT TO THE 7/15/2011 POWER PURCHASE AGREEMENT BETWEEN FRESH AIR ENERGY IV LLC, AND PACIFIC GAS AND ELECTRIC COMPANY.

THIS SECOND AMENDMENT ("Second Amendment") is entered into by and between PACIFIC GAS AND ELECTRIC COMPANY ("PG&E") and FRESH AIR ENERGY IV, LLC ("FAE") for the Sonora 1 project. PG&E and FAE may be referred to herein individually as "Party" and collectively as "Parties." All capitalized terms not defined herein shall have the meaning set forth in the PPA, as defined below.

RECITALS

Whereas, Ahura Energy Concentrating Systems, Inc. ("Ahura") and PG&E executed that certain Power Purchase Agreement, dated July 15, 2011 ("PPA") for the Sonora I project;

Whereas, Ahura and PG&E executed the First Amendment to that certain Power Purchase Agreement dated March 28, 2012 ("First Amendment");

Whereas, Ahura, Fresh Air Energy III, LLC and PG&E executed that certain Consent to Assignment and Agreement, dated April 18, 2012 (the "First Assignment");

Whereas, Fresh Air Energy III, LLC, Fresh Air Energy IV, LLC and PG&E executed that certain Consent to Assignment and Agreement, dated June 21, 2013 (the "Assignment");

Whereas, Fresh Air Energy IV, LLC, now holds the entirety of the Seller's rights, title and interest in the PPA;

Whereas, the Parties desire to amend the PPA in order to reflect a modification to the address as recognized by Tuolumne County, which does not change the physical location of the Facility;

NOW, THEREFORE, in consideration of the mutual promises and covenants contained herein, PG&E and FAE agree as follows.

I. Amendment of the PPA

(a) The first sentence of Section 2.1.1 of the PPA, Facility location, shall be deleted and replaced with the following:



(b) The second paragraph of Section 2.1.8 of the PPA, name and address of electric service account, shall be deleted and replaced with the following:
