FIRST AMENDMENT TO THE POWER PURCHASE AGREEMENT BETWEEN RISING TREE WIND FARM II LLC

THE FIRST AMENDMENT ("First Amendment") is entered into by and between PACIFIC GAS AND ELECTRIC COMPANY ("PG&E") and RISING TREE WIND FARM II LLC

for the Facility described as Rising Tree Wind Farm II LLC ("the Facility").

PG&E and Rising Tree Wind Farm II LLC may be referred herein individually as "Party" and collectively as "Parties." All capitalized terms not defined herein shall have the meaning set forth in the PPA, as defined below.

RECITALS

Whereas, Rising Tree Wind Farm II LLC and PG&E executed that certain Power Purchase Agreement for the Facility, dated October 25, 2013 ("PPA");

Whereas, the Parties desire to amend the PPA in order to reflect a modification in the Facility location;

NOW, THEREFORE, in consideration of the mutual promises and covenants contained herein, PG&E and Rising Tree Wind Farm II LLC agree as follows.

1. Amendment of the PPA

a) The Description of Units set forth in Section B(xii) of the Cover Sheet shall be deleted and replaced with:

The following provides the legal descriptions and assessor's parcel numbers for those parcels on which Seller expects the generating facility to be located:


