Mr. Magnuson introduced the following bill; which was read twice and referred to the Committee on Commerce

## A BILL

To authorize the Secretary of Transportation to prescribe safety regulations for the transportation of natural gas by pipeline, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 That this Act may be cited as "the Natural Gas Pipeline
- 4 Safety Act of 1967".
- 5 SEC. 2. The first full paragraph of section 831, title 18,
- 6 United States Code, as amended, is amended by adding, im-
- 7 mediately before the first "and", the following: "and any
- 8 entity whether privately, publicly, or cooperatively owned,
- 9 which gathers, transmits, or distributes natural gas, manu-
- 10 factured gas, or other flammable gas by pipeline (whether

- 1 or not regulated by the Federal Power Commission),".
- 2 SEC. 3. Section 834, title 18, United States Code, as
- 3 amended, is amended by redesignating present subsection (f)
- 4 as subsection (g) and adding a new subsection (f) as
- 5 follows:
- 6 "(f) Such regulations concerning natural, manufac-
- 7 tured, or other flammable gas shall apply to the design, in-
- 8 stallation, inspection, testing, construction, extension, opera-
- 9 tion, replacement, and maintenance of existing and proposed
- 10 gas pipelines and appurtenant facilities, and may provide that
- 11 safety inspections required thereby be conducted by inspec-
- 12 tion agencies which satisfy such standards of competence and
- 13 independence from the owner, builder, or operator of the
- 14 pipeline as the Secretary of Transportation (hereinafter
- 15 referred to as "the Secretary") may prescribe. Nothing in
- 16 this section shall be deemed to restrict the authority of the
- 17 Federal Power Commission under the Natural Gas Act, nor
- 18 shall anything in this section be deemed to prohibit any State
- 19 from establishing additional regulations for the safety of gas
- 20 pipelines and appurtenant facilities which are not incom-
- 21 patible with Federal regulations prescribed pursuant to this
- 22 section. The Secretary may, under procedures established
- 23 by him, provide for the waiver of any gas safety regulations
- 24 prescribed by him under this section. The Secretary shall
- 25 maintain safety records of companies transporting gas by

pipeline; notify the appropriate Federal and State agencies 1 of violations of any gas safety regulations prescribed under 2 this section; consult with and advise the Federal Power 3 Commission before prescribing any regulations covering gas 4 transmission; establish procedures under which new mate-5 rials, operations, devices, and processes may be qualified 6 without undue delay to comply with gas safety regulations 7 prescribed under this section; and upon request of the Fed-8 eral Power Commission, advise the Federal Power Commis-9 sion of the safety of any materials, operations, devices, or 10 processes not expressly encompassed by such regulations. 11 Whenever the issuance of a regulation or action upon appli-13 cation for waiver would affect continuity of any services au-14 thorized by the Federal Power Commission, the Secretary shall consult with and advise the Federal Power Commission 16 before taking such a step and shall defer the effective date of 17 his requirements until the Federal Power Commission has 18 had reasonable opportunity to grant the authorizations it 19 deems necessary.
