MAJOR CONTROL FACILITIES: INSPECTION, OPERATION, AND MAINTENANCE GAS MEASUREMENT AND CONTROL MANUAL

#### **PURPOSE**

 To establish the procedure for inspection, operation, and maintenance of major gas regulating and control station equipment, and the associated record keeping.

#### POLICY

2. System control facilities shall periodically be inspected, tested, and maintained according to this Standard Practice, and the current General Order Number 112 of the California Public Utilities Commission.

#### RESPONSIBILITY

- 3. The Manager of Gas System Design Department shall publish the necessary information on inspection, operation and maintenance, and set forth the requirements; in appropriate manuals, drawings, procedures, schedules, and record forms for each of the subject facilities.
- 4. The Regional Gas Operations Managers and the Pipe Line Operations Manager are responsible for performing the inspection, operation and maintenance of the subject facilities, within their assigned geographical area in accordance with Gas System Design Department's directives described in Paragraph 5.
- 5. Each of the subject facilities is delineated in the "Operating Maps and Diagrams," showing the organization to which the facility is assigned. When such assignment is not specifically stated, the Regional Gas Operations Manager in whose area the facility exists, will be responsible for the inspection, operation and maintenance of the facility.

#### SCHEDULES

\*\*6. The inspection and maintenance frequency shall be established by the Gas System Design Department in coordination with the Regions and Pipe Line Operations Department.
