• Bucket full with water and soap solution	
• Soil saturated with soapy water	
• Ground rod inserted into wet soil	
• Ground cable attached to ground rod and to squeezer	
• Pour soapy solution on and around rupture point	
• Thoroughly rinse off pipe after coming into contact with soap or other detergents	
5. Squeezing Down Procedures:	<input type="checkbox"/>
• Be sure that all grounding procedures are in place	
• Center squeezer onto pipe	
• Install squeezer at least 3 pipe diameter away	
• Close squeezer down slowly, until gas flow stop (1" of travel per 1 minute)	
6. Release Squeezer Procedures:	<input type="checkbox"/>
• Release the squeezer slowly, (1" of travel per 1 minute)	
• Remove squeezer from pipe	
• Remove grounding cable	
• Re-shape the plastic pipe
